EXPO HIGHTEX 2017 RULES AND REGULATIONS

SPACE ASSIGNMENT

General booth sales will begin on July 6, 2016. Contracts are assigned booth space on a first-come, first-served basis. The Groupe CTT Inc. will attempt to honour an Exhibitor's request for booth space and his/her desires; however, the Groupe CTT Inc. reserves the right to assign an Exhibitor to the best space available should his/her choices be unavailable.

PAYMENT INFORMATION

A 50% deposit (100% for international companies with the exception of the U.S.) is required along with the signed contract. All balances are due in full by January 6, 2017. All booths not paid in full by January 6, 2017, will be released. All contracts received after January 6, 2017, must include 100% payment to secure booth space. Contracts will not be accepted without full payment. Credit cards are accepted for payment. Credit card information will be processed upon receipt. Checks must be made out to the Groupe CTT Inc. and payable through a Canadian or U.S. bank. Final payment is due within 30 days of invoice date OR January 6, 2017, whichever comes sooner. Exhibitors will be invoiced by December 2017. If the Groupe CTT Inc. does not receive the balance on January 6, 2017, or if the Exhibitor has delinquent accounts with the Groupe CTT Inc., Groupe CTT Inc. reserves the right to cancel this contract and release the booth space for resale purposes. All previously paid money will be forfeited. Contracts received from companies that have any outstanding balances due to the Groupe CTT Inc. will not be processed without full payment of delinquent accounts.

STANDARD BOOTH EQUIPMENT

Minimum booth space size is 10' x 10' or 100 square feet (inline). Booth space rental includes a draped backwall with draped side rails, an ID sign with company name, a 6' draped table and 2 chairs. No display or sign can exceed 10' high.

EXPO FLOOR PLAN

The Groupe CTT Inc. reserves the right to rearrange the Expo Floor at any time. The Groupe CTT Inc. also reserves the right to relocate Exhibitors should it become necessary for causes beyond the Groupe CTT Inc.'s control or advisable in the best judgment of the Groupe CTT Inc.

CANCELLATION OF EXPO

In the event any part of the Exhibit Hall is destroyed or damaged so as to prevent the CTT Groupe Inc. from permitting an Exhibitor to occupy the assigned booth space during any part of or for the whole Expo period, or in the event occupation of assigned booth space during any part of or for the whole Expo period is prevented by strikes, natural disasters, national emergency or other causes beyond the control of the CTT Groupe Inc., this agreement shall terminate and the said Exhibitor shall and does hereby waive any claim for damages or compensation against the CTT Groupe Inc., its officers, directors, agents or employees, except the pro rata return of the booth space rental paid after deduction of actual expenses incurred by the CTT Groupe Inc. in connection with the Expo. There shall be no further liability on the part of either party.

CANCELLATIONS/REDUCTIONS

All cancellations or reductions of space must be received by January 7, 2017, will be entitled to a refund minus a 25% fee of the unused booth space. Notifications received after January 7, 2017, will not be entitled to any refund and the Exhibitor shall remain liable for the total amount of the unused booth space. Booths will be reassigned. Exhibitor may be required to move locations if they request a reduction in space. Money cannot be carried over to the following year. Any cancellation without payment is liable for a 25% fee of unused booth space.

SUBLETTING

The space applied for is to be used solely for the Exhibitor whose name appears on the contract. Only the Exhibitor name which appears upon the face of this contract may be used to identify the leased booth space at the Expo and in all official Exhibitor listings. The Exhibitor may not assign, sublet or sublicense any part of the booth space. In the case of exhibiting companies that are affiliates or wish to share leased booth space, an official request must be submitted by each company to Groupe CTT Inc. Each request will be reviewed individually by the Groupe CTT Inc. The Groupe

CTT Inc., its representatives, committees, agents and members shall not be liable for any damage arising in any manner, directly or indirectly, from such rejection.

PHOTOGRAPHY

Groupe CTT Inc. has permission to use the likeness of any person and/or products exhibited in photographs and in any and all other media, whether now known or hereafter existing. The exhibitor waives the right to inspect or approve the finished product, including written or electronic copy. Additionally, all rights to royalties or other compensation arising or related to use of the photograph are waived by the Exhibitor.

LIABILITY AND INDEMNIFICATION

Exhibitor shall be fully responsible for and hereby releases the Groupe CTT Inc. from any claims, liabilities, losses, damages or expenses relating to or arising from an injury to any person, or any loss of or damage to property where such injury, loss, or damage is incident to, arises from, or is in any way connected with Exhibitor's participation in the Expo. The Exhibitor shall protect, indemnify, hold harmless and defend the Groupe CTT Inc., its officers, directors, agents and employees against all claims, liabilities, losses, damages and expenses, including reasonable attorney's fees and costs of litigation arising in any manner, directly or indirectly, from Exhibitor's participation in the Expo; provided that the foregoing indemnification shall not apply to injury, loss or damage caused by or resulting from the sole negligence of the Groupe CTT Inc., its officers, directors, agents or employees. It is the Exhibitor's sole responsibility to obtain, at its own expense, any or all licences and permits to comply with all federal, state and local laws and City of Montreal, QC, ordinances for any activities conducted in association with or as part of the Expo.

INSURANCE

Each Exhibitor is required to carry insurance, for its own protection and entirely at its expense, a minimum of \$1 million single limit bodily injury and broad form property damage coverage, naming the Groupe CTT Inc. Any policy providing such insurance must contain an express waiver by the Exhibitor's insurance company of any right of subrogation as to any claims against the Groupe CTT Inc., its officers, directors, agents or employees. The Groupe CTT Inc., and their officials, officers, agents, representatives, employees will insure Exhibitor's property or assume responsibility or liability for any theft, damage or loss by any cause of property of the Exhibitor, its agents or employees, nor for any injury that may occur to the Exhibitor, its agents or employees.

AUTHORITY OF SHOW MANAGEMENT

The Groupe CTT Inc. shall have full power in the matter of interpretation, amendments and enforcement of all said Rules & Regulations. The Groupe CTT Inc.'s interpretation and decision are final. Any amendments to the contract with the Exhibitor must be done so in writing and signed by both parties to be binding.
